Key compliance dates

31 January 2025

BVI Approved Managers - deadline to provide Annual Report to the BVI Financial Service Commission (FSC).

BVI Incubator Funds - deadline to submit semi annual and annual returns to the BVI FSC.

BVI Approved Funds - deadline to submit annual returns to BVI FSC.

Payment of license fees due to the FSC for all entities regulated under the Banks and Trust Companies Act.

Trust and Corporate Services Provider Annual Return.

31 March 2025

BVI FSC registered/licensed entities (including approved managers) deadline to pay annual fee to BVI FSC.

SIBA or BTCA entities - deadline to submit anti-money laundering compliance filing.

1 April 2025

BVI FATCA defined financial institutions deadline to complete their annual FATCA registration with the BVI Internal Tax Authority (the "ITA") and pay the registration fee.

30 April 2025

Financial institutions under the BVI CRS definition deadline to complete annual CRS registration with the BVI ITA and pay registration fee.

BVI Limited Partnerships deadline for payment of annual fees to the Registrar of Companies.

31 May 2025

Financial institutions submit FATCA and CRS Annual Returns under BVI FATCA CRS definition.

Annual fees for companies incorporated between 1 January and 30 June due to the registrar to companies.

30 June 2025

Deadline for submitting audited financial reports to BVI FSC (Excepted application for exemption or designation of fund type).

Submit Economic Substance declarations to ITA (BVI companies and limited partnerships for fiscal year ending December 31).

All companies must have filed their Register of Members and Register of Beneficial Owners with the Registry of Corporate Affairs.

31 July 2025

BVI Incubator Funds - deadline to submit half – year report to BVI FSC as of 30 June.

30 September 2025

Deadline for submitting Financial Annual Return to your Registered Agent for BVI companies with a fiscal year ending December 31.

30 November 2025

Deadline for companies incorporated between July 1 and December 31 to pay annual fees to the Registrar of Companies.

31 December 2025

Deadline to file Register of Members and Register of Beneficial Owners at the Registry of Corporate Affairs.
